## HEALTH HAZARD INFORMATION

### Health Effects:

The following health effects refer to the sawdust from non treated Australian hardwood, based on current research and knowledge.

### Acute Health Effects:

<b>Swallowed:</b>	Unlikely under normal conditions. Swallowing wood dust may cause abdominal discomfort.
<b>Eye:</b>	Wood dust is irritating to the eyes resulting in redness and watering.
<b>Skin:</b>	Skin contact with wood dust may cause skin irritation.
<b>Inhaled:</b>	Inhalation of wood dust may be irritating to the nose, throat and lungs.

### Chronic Health Effects:

<b>Chronic:</b>	Repeated inhalation of wood dust may increase the risk of nasal cavity cancer. Exposure to wood dust is associated with respiratory and skin sensitisation resulting in asthma and dermatitis respectively. Repeated contact with green timber may cause dermatitis.

However, if the work practices noted in this MSDS are followed, and exposure to airborne dusts are kept low, no acute or chronic health effects are anticipated.

- First Aid:** If poisoning occurs, contact a doctor or Poisons Information Centre.
- Swallowed:** Give water to drink. Seek medical attention if any abdominal discomfort.
- Eyes:** Flush thoroughly with water for at least 15 minutes. If irritation persists seek medical attention.
- Skin:** Wash thoroughly with mild soap and water. Remove clothing if contaminated with wood dust.
- Inhaled:** Leave the dusty area.

## PRECAUTIONS FOR USE

**Exposure standards:** Worksafe Australia Exposure Standard. There is no specific Exposure Standard for wood dust from Australian Hardwood, but the following should apply.

**Hyne Timber Recommendation:** Keep exposure as low as practicable with the aim of maintaining inspirable wood dust levels below 1.0 mg/m<sup>3</sup> TWA.

**Engineering controls:** All work must be carried out in such a way as to minimise exposure to wood dust. Local exhaust ventilation devices capable of removing dust at the source or fans to create artificial ventilation could be used to remove wood dust from the workers breathing zone. Measures should be taken to eliminate the build up of static electricity.

**Respiratory Protection:** If engineering controls are not practical then respiratory devices may need to be worn. Avoid breathing wood dust from non treated Australian hardwood. Wear a P1 or P2 respirator suitable for particulate and conforming with Australian Standards AS/NZS 1715 and AS/NZS 1716 when exposed to dust. These standards should be followed in the selection, fit-testing, use, storage and maintenance of the respirators.

**Skin Protection:** Wear protective gloves (AS/NZS 2161.1), loose comfortable clothing and boots. Long sleeved shirts and long trousers are recommended if skin irritation occurs. Wash skin with mild soap and water after working with non treated Australian hardwood chip. Launder work clothes regularly and separately from other clothes.

<b>Eye protection:</b>	Non-fogging goggles or safety glasses (AS/NZS 1337) should be worn if there is a risk of wood dust getting into the eyes.
<b>Flammability:</b>	Not flammable under normal conditions of use, but is combustible and will help sustain a fire.

## SAFE HANDLING INFORMATION

<b>Storage:</b>	Store in a well ventilated area away from sources of heat, flame, sparks or other contamination.  While no special transport requirements are recommended, it should be noted that this product can spontaneously combust. Avoid confining this product for long periods of time in poorly ventilated containers.
<b>Road and Rail Transport:</b>	Not classified as Dangerous Goods by the criteria of the Australian Dangerous Goods Code (ADG Code) for transport by Road and Rail.
<b>Marine Transport:</b>	Not classified as Dangerous Goods by the criteria of the International Maritime Dangerous Goods Code (IMDG Code) for transport by sea.
<b>Air Transport:</b>	Not classified as Dangerous Goods by the criteria of the International Air Transport Association (IATA) Dangerous Goods Regulations for transport by air.
<b>Spills and disposal:</b>	Waste material should be placed in containers and disposed of at approved landfill sites or incinerated in accordance with local authority guidelines. Non treated Australian hardwood chip can be burnt in open fires, stoves, fireplaces and residential boilers.
<b>Fire/explosion hazard:</b>	Wood chip will help sustain a fire and the dust may form an explosive mixture with air. Avoid sparks, the build up of static electricity and sources of ignition in all electrical equipment and dust extraction equipment.
<b>Fire Fighting:</b>	In a fire, use water jets to extinguish flames.
<b>Suitable extinguishing media:</b>	If material is involved in a fire use water, fog (or if unavailable fine water spray), foam, dry agent (carbon dioxide, dry chemical powder).
