4. FIRST AID MEASURES

If poisoning occurs, contact a doctor or Poisons Information Centre (Phone Australia 131 126, New Zealand 0800 764 766).

The following first aid measures are for exposure to dust generated when the product is worked in any manner that results in wood dust being generated.

Inhalation: Remove victim from exposure – avoid becoming a casualty. Allow patient to assume most comfortable position and keep warm. Keep at rest until fully recovered. Seek medical advice if effects persist.

Skin contact: If skin or hair contact occurs, remove contaminated clothing and flush skin and hair with running water. If swelling, redness, blistering or irritation occurs seek medical assistance.

Eye contact: If in eyes wash out immediately with water. In all cases of eye contamination it is a sensible precaution to seek medical advice.

Ingestion: Rinse mouth with water. If swallowed, DO NOT induce vomiting. Give a glass of water to drink. Never give anything by mouth to an unconscious patient. If vomiting occurs give further water. Seek medical advice.

Notes to physician: Treat symptomatically.

5. FIRE-FIGHTING MEASURES

Specific hazards: Combustible material. In common with many organic chemical, may form flammable dust clouds in air.

Fire fighting further advice: On burning may emit toxic fumes. Fire fighters to wear self-contained breathing apparatus and suitable protective clothing if risk of exposure to vapour or products of combustion.

Suitable extinguishing media: If material is involved in a fire use water fog (or if unavailable fine water spray), foam, dry agent (carbon dioxide, dry chemical powder).

6. ACCIDENTAL RELEASE MEASURES

For dust. Avoid accidents, clean up immediately. Wear protective equipment to prevent skin and eye contamination and the inhalation of dust. Work up wind or increase ventilation. Cover with damp absorbent (inert material, sand or soil). Sweep or vacuum up, but avoid generating dust. Collect and seal in properly labeled containers or drums for disposal. If contamination of sewers or waterways has occurred advise local emergency services.

7. HANDLING AND STORAGE

Handling: Avoid eye contact and repeated or prolonged skin contact.

TWA – (Time-Weighted Average) - the airborne concentration over an eight-hour working day, for a five-day working week over an entire working life.

STEL – (Short Term Exposure Limit) – the average airborne concentration over a 15 minute period which should not be exceeded at any time during a normal eight-hour day.

'Sen' – (Sensitizer notice) – the substance can cause specific immune response in some people. An affected individual may subsequently react to exposure to minute levels of that substance.

These exposure standards are guides to be used in the control of occupational health hazards. All atmospheric contamination should be kept to as low a level as is workable. These exposure standards should not be used as fine dividing lines between safe and dangerous concentrations of chemicals. They are not a measure of relative toxicity.

If the directions for use on the product label are followed, exposure of individuals using the product should not exceed the above standard. The standard was created for workers who are routinely, potentially exposed during product manufacture.

Biological Limit Values: As per the “National Model Regulations for the Control of Workplace Hazardous Substances (Safe Work Australia)”, the ingredients in this material do not have a Biological Limit Value allocated.

Engineering Measures: Ensure ventilation is adequate to maintain airborne concentrations below Exposure Standards. Avoid generating and inhaling dusts. Use with local exhaust ventilation or while wearing a dust mask.

Personal Protection Equipment: OVERALLS, SAFETY SHOES, SAFETY GLASSES, GLOVES, RESPIRATORY PROTECTION.

Wear overalls, safety glasses and impervious gloves. Avoid generating and inhaling dusts. If dust exists, wear a dust mask or respirator meeting the requirements of AS/NZS 1715 and AS/NZS 1716. Available information suggests that gloves made from leather should be suitable for intermittent contact. However, due to variations in glove construction, type and local conditions, the user should make a final assessment prior to selection and use. Always wash hands before smoking, eating, drinking or using the toilet. Wash contaminated clothing and other protective equipment before storing or reusing.
